



Hobart Airport “Summer Rewards” Terms and Conditions

1. Hobart International Airport Pty Ltd (**HBA**) is carrying out a “Summer Rewards” Promotion.
2. The Promotion will be run from **Tuesday 1 January** until **Thursday 31 January 2019**.
3. Employees of HBA and their immediate families, HBA suppliers and providers, and agencies associated with this Promotion are ineligible to enter.
4. To enter the Promotion, entrants must incur the minimal spend (in one transaction) at a participating outlet at Hobart Airport to receive two skill tester tokens. The minimum spend for food and beverage outlets is **\$15**. The minimum spend for retail outlets is **\$20**.
5. Entrants must use the tokens to play the “skill tester machine” and to capture a wombat or Tasmanian devil stuffed toy, to which a random prize tag will be attached
