• Air NZ has seen growth year on year, particularly in December. Seasonal service to Auckland finishes 27 March 2025, with the service returning in October 2025.

#### Antarctic operations

• C17 and Operation Southern Discovery returned on 24 February 2025, re-establishing the critical connection between Hobart and Wilkins Aerodrome

#### Aviation Attraction Fund

- \$5 million Aviation Attraction Fund launched in January by State Government to increase domestic flights to and from Tasmania and enhance potential for new international routes.
- Now open for applications by airports and airlines

#### Project Update - Terminal

- building footprint extending to meet the current roadways.
- More space being created for departures and car rentals
- The Qantas Lounge will be temporarily relocated from April
- New checked baggage screening will be installed per Federal Government mandates from May, and new passenger security screening area with body scanners and new carry-on baggage screening will be implemented from June

#### Airfield Upgrade

- About 65% of the project completed including widening taxiways, bay works and runway strengthening to support wide body aircraft. Work on the apron completed in February.
- Runway works occurring nightly section by section, completed and ready to receive the next morning's first flight.
- Works are due to be completed mid-year

#### West Holyman car rental precinct development

- long-term plan to move back of house infrastructure and aligned services to new location off Holyman Drive, increasing public car park capacity close to airport
- Flood modelling and traffic flow impact studies completed and materials from previous projects re-cycled approx 21,500 m3 of fill transported in from the last runway lengthening project.
- Luke Moore Civil has been awarded the contract for the works.

#### Community Update

 Hobart Airport now naming rights sponsor of the Southern Football League supporting grassroots and premier league football across 14 clubs and over 2000 players in both men's and women's teams.

	A detailed update was provided by Airservices including:	
	• An update on complaint data from the last 5 months. It was noted that	
	15 individual complainants made 252 contacts, 10 suburbs recorded	
	complaints with six of these recording a single complainant. The main	
	reasons for complaints included standard flight path movements,	
	unusual movements including weather diversions and traffic	
	management, noise abatement trial and helicopters.	
	• Runway 12/30 operations were explained, noting that runway use is	
	dictated by weather conditions.	
	• The group discussed complaints data, with a recommendation to access	
	complainant data via the Air Services website
